REQUEST FOR COUNTER-SIGNING OF SHIPPING GUARANTEE

Quantity and description of goods

In making this application for the release of goods under the said Shipping Guarantee, *I/we authorise you

- a) to debit *my/our account number _____ for the sum of _____

as a marginal deposit held by you in accordance with General Security Agreement Relating to Goods or Trade Financing General Agreement.
- b) to effect payment of the relative bill on presentation even when documents contain discrepancies.
- c) to debit *my/our account without further notice or claim on *me/us in respect of any balance owing to you by *me/us in connection with this item.

In consideration of your countersigning the said Shipping Guarantee *I/we hereby agree:

- 1) that *I/we will at all times indemnify you and keep you indemnified against all liability in respect thereof and against all actions, suits, proceedings, claims, costs and expenses whatsoever which may be taken or made against you or incurred or become payable by you in respect thereof.
- 2) that *I/we shall duly honour and discharge all drafts presented to *me/us relative to the said goods.
- 3) that *I/we shall duly honour the terms of your General Security Agreement Relating to Goods or Trade Financing General Agreement.
- 4) that on the receipt of the Bill of Lading for the said goods *I/we shall deliver the said Letter of Indemnity to you for cancellation.
- 5) that until the cancellation of the said Shipping Guarantee and until the due payment of all drafts relating to the said goods the Bill of Lading if made out to *me/us shall on receipt be endorsed to you and that in any event the said goods shall be received by *me/us to hold the same and the proceeds thereof in trust on your behalf.
- 6) that should the said Shipping Guarantee not be released to you within one calendar month from the date of issue *I/we shall pay you a commission at the rate ruling at the date of issue in accordance with your tariff irrespective of whether the Bill of Lading is received through your agency.
- 7) to be bound by the consent clause appearing on the reverse of the form.

Customer Consent

To enable you to provide or consider whether to provide us with services, we are required to supply to you, personal, account and transactional information ("Customer Information").

Subject to you agreeing to provide such services as we may request, you will use, store and transfer (whether within or outside Singapore) and/or exchange such details and information to or with all such persons as you may consider necessary. We agree and acknowledge that overseas service providers may be required by law to disclose information received from you to third parties. Such circumstances include the service provider being compelled to disclose information pursuant to a court order, police investigations and criminal prosecutions for tax evasion or other offences.
