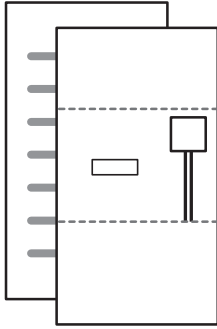
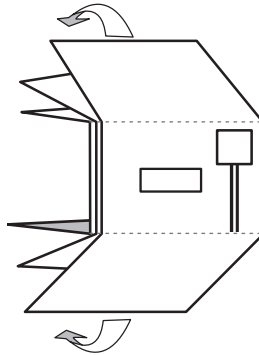

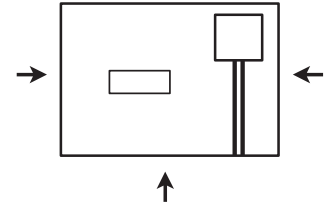
How to use the Business Reply Envelope (BRE)

By applying for this Service, you agree to be bound by these terms and conditions: HSBC debit card, HSBC credit cards not issued in Singapore, HSBC Corporate and US dollar credit cards are ineligible for this Service. Only duly completed applications will be processed. • Your eligibility for this Service is also subject to approval from the respective organisations. • If your existing recurring bill payment arrangement with the relevant organisation is by GIRO, the GIRO payment arrangement must be terminated before you apply for this Service. • HSBC is entitled to at least six weeks to process your application, upon receipt of your application. • During the processing period, you shall continue to make payment to the relevant organisations until such time as the first recurring payment is charged to your HSBC credit card and reflected on your monthly HSBC credit card statement. • HSBC will not notify customers separately on their application status.
