    - 5. operational resilience and data management practices; or
    - 6. taxation and transfer pricing practices; or

- d. We can choose how to give this notice to you. This may include:
  - i. contacting you directly (through mail, email, post or via mobile);

  - iii. publishing the change on our website; and

- e. If you don't agree with a change, you can cancel your existing credit card, after paying all amounts you may owe us.

- 14. **"Eligible Credit Card"** means any primary or additional HSBC Privé issued by HSBC Bank (Singapore) Limited and its successors and assigns.

- 16. "we", "us" or "our" means HSBC Bank (Singapore) Limited and its successors and assigns.
- 17. **"you" or "your"** means the person to whom we issue an Eligible Credit Card that is eligible for the Offer.
