

Terms and Conditions Governing HSBC Debit Card GSS Lucky Draw Campaign June - July 2018

1. This Promotion is valid from 1 June to 31 July 2018 (both dates inclusive) or such other date(s) as may be determined by HSBC Bank (Singapore) Limited ("HSBC" or the "Bank") at its discretion ("Promotional Period").
2. This Promotion is offered by HSBC to all HSBC customers who hold a valid Debit Card (as defined below) issued by the Bank in Singapore ("Eligible Customers").
3. Each Eligible Customer will receive:
 - a. one opportunity to win a full rebate of the Eligible Transaction(s) made by him/her during the Promotional Period (the "Prize") for each local Eligible Transaction entered into by such Eligible Customer; and
 - b. two opportunities to win the Prize for each overseas Eligible Transaction entered into by such Eligible Customer.
4. The Prize is subject to a maximum rebate of S\$500 per Eligible Customer. 20 Eligible Customers will be selected to receive a Prize in accordance with clause 7 below (each such Eligible Customer, a "Winner").
5. "Eligible Transaction" means any successful local or overseas transaction of least S\$5 made and charged in full payment to a Debit Card using Visa functionality with the transaction date falling within the Promotional Period, provided that the following transactions shall not constitute valid Eligible Transactions for purposes of this Promotion:
 - a. transactions using NETS functionality; or
 - b. transactions using QuickCash functionality; or
 - c. transactions using ATM functionality; or
 - d. fees and charges imposed by the Bank; or
 - e. any transaction charged to the Debit Card during the Promotional Period that is subsequently cancelled, voided or reversed.
6. "Debit Card" means an Eligible Customer's debit card issued by HSBC in Singapore bearing the name/service mark of VISA which is linked to the Eligible Customer's deposit transactional account for purposes of settlement of debit card transactions and governed by The HSBC Debit Card Cardholder's Agreement.
7. Drawing of the Winners will be conducted in the HSBC office at Mapletree Business City in September 2018 or on such other date and time as may be notified by HSBC.
8. Each qualifying Eligible Customer may only receive a maximum of one Prize, regardless of the number of Debit Cards held by such Eligible Customer.
9. The Prize shall be forfeited if the relevant Debit Card account is suspended or terminated during the Promotional Period.
10. The Winners will be notified by mail or such other forms of communications which may be determined by HSBC.
