- For any early repayment of Debt Consolidation, I shall either (i) give the Bank a minimum of 30 days' notice, or (ii) subject to the Bank's approval, pay the Bank 30 days' interest on the amount repaid in lieu of such notice period.
- Upon approval of my request, the Bank will send a repayment letter to my address on record, stating the exact repayment amount(s), early repayment fee, and the date(s) on which my payment(s) should be made.
- If I fail to make the necessary payment(s) on the stipulated date(s), this repayment request will be void, and I will need to issue a fresh repayment request where a fresh 30-day notice period will apply.
- Upon full repayment of Debt Consolidation, the Revolving Credit Facility (ie. HSBC Visa Platinum Credit Card) will be closed.
