

HSBC Online Unit Trust Promotion ("Promotion") Terms and Conditions

- This Promotion is offered by HSBC Bank (Singapore) Limited ("HSBC" or "the Bank") to all new and existing customers of the Bank (excluding staff) ("Eligible Customers") from 1 January 2025 to 31 December 2025 (both dates inclusive) or such other date(s) as may be determined by HSBC at its discretion ("Promotional Period").
- 2. Eligible Customers who purchase any unit trust via lump sum payment during the Promotional Period via the Bank's Online Unit Trust channel will enjoy a sales charge of 0.85% for all such unit trust transactions.

Eligible Customers who purchase any unit trust via a Regular Saving Plan (RSP) placed during the Promotional Period via the Bank's Online Unit Trust channel will enjoy a discounted sales charge of 0.85% on their initial contribution. On top of the discounted initial sales charge, Eligible Customers can also enjoy a sales charge of 0% on their monthly RSP contributions for the first 6 months.
- 4. The Bank may, at its discretion, revise these promotional terms and conditions (including but not limited to varying the Promotional Period) or withdraw this Promotion at any time without prior notice.
